Seeking & Obtaining Funeral Services

A Guide for Bereaved Childbearing Families and Advocates

First Call

When a baby dies, families may not know who to call, what to ask, or what to expect from a funeral home. Some common questions and concerns are discussed in this brochure.

What Will I Need To Tell The Funeral Director?

When you call a mortuary, the funeral director may ask who you are in relationship to the baby who died (mother, father, grandparent, friend of family, etc.), where the baby's body is, and when the baby died. The funeral director may ask you who the baby's doctor was. If your baby was stillborn at the hospital, your baby's doctor is usually your obstetrician or family doctor. If your baby was born alive, the doctor might be a neonatologist or pediatrician. The funeral director might ask you some questions about what services you want. Asking about the kind of service (funeral, cremation, memorial, etc) helps the funeral director to start planning how to best help you through such a difficult time.

While talking with you, the funeral director may ask about scheduling a time to meet with you personally to make further arrangements for your baby's service and complete necessary forms. If you are still in the hospital you may not know when you are going to be dismissed. You may want to delay scheduling an appointment until you know for sure when you can leave the hospital. The funeral director can arrange to receive your baby at the funeral home while you are still in the hospital waiting to be dismissed. Try to take some time to rest at home a little before meeting with the funeral director. It is ideal if both mother and father can meet with the funeral director together.

Payment

Funeral Homes typically offer SERVICES and funeral SUPPLIES. Each service and each supply may have a specific cost or several items may be grouped together as a 'package'.

• BASIC SERVICES is a fee that includes business overhead and services the funeral home provides to assist you such as conducting arrangements conferences, securing necessary permits and completing paperwork, caring for the deceased child's body, coordinating with the cemetery or crematory and related businesses and services.

• ITEMIZED SERVICES include transportation of the deceased child, embalming, cremation, or use of staff and facilities for visitation, funeral, or memorial services.

• SUPPLIES or MERCHANDISE may include casket, outer burial container, urn, and printed items such as memorial folders, prayer cards, or register or remembrance books.

• CASH ADVANCE items are things which the mortuary doesn't directly provide but can obtain for your baby's service. Usually these items must be paid for immediately. They may include such things as a newspaper obituary, flowers, grave space, or other cemetery fees.

Mortuary services and supplies which you request directly from the mortuary will generally be charged according to an agreement between you and the funeral home serving you. Your funeral director will provide you with a written contract that describes the services and supplies you have requested and their costs. You will be asked to sign this contract.

Be Informed

Choosing a funeral provider who respects the preciousness of your child and will make every effort to meet your needs is important.

Before calling any mortuary, write down your questions. Ask someone to help you if possible. Take notes while on the phone. Make an informed decision.
